Club Rules

1. The Devon and Somerset Condors Hang Gliding and Paragliding Club exist to promote all aspects of the above sports.
2. At its annual General Meeting (March) the club shall elect a committee comprising, Chairman, Secretary, Treasurer, Safety and Sites officers. Any other officers deemed necessary to be elected by a majority vote.
3. Reasonable measures to be taken to notify full members of date, or any changes to date of AGM.
4. The committee shall have the power to co-opt members onto the committee by a majority vote.
5. If five committee members, (a quorum) are not present at a committee meeting the chairman may co-opt full members as necessary. If the Chairman is not present at any meeting the committee can elect one of their number to be Chairman for that meeting.
6. The committee may, at its discretion, replace any committee member who is absent from three consecutive committee meetings.
7. The committee may, by a majority vote, impose such "committee rules" as it deems necessary to the safety and enjoyment of members of the club.
8. Club Rules may be changed at a club meeting by a majority vote and ratified at the following AGM.
9. An EGM may be called by either a 75% majority of committee members or by 75% of club members.
10. In the event of a tie in any vote the chairman shall have the casting vote.
11. A statement of the accounts of the club to be presented annually.
12. Members only may serve on the committee.
13. Members only may vote at the AGM.
14. Members only eligible to enter the club's Cross Country League, Rules for club competitions to be decided by the club.
15. All members of the club to be members of the BHPA or must be able to provide proof of airports third party liability insurance to the value of £2,000,000.
16. The cost of membership to be decided at the AGM.
17. The committee shall have the power to expel any member whose conduct it considers to be injurious to the sport or club, having given them a reasonable opportunity to explain their actions.
18. All members are expected to abide by current club and committee rules.
19. Membership shall be obtained prior to flying any site nominated by the club as being members only, due to landowner stipulation or other legal requirement.
